Awards:

Ribbons 1st-6th place for each class; Champion and Reserve Champion (highest average score of two or more tests) for each level Intro - First
Cohen High Score Award – highest percentage at each level: Intro, Training, First, Second/Above (sponsored by Amy & David Cohen)
Howard J. Morris Perpetual Trophy - awarded to the highest scoring MADCTA member (sponsored by MADCTA in memory of Col. Howard J. Morris)
Pinchona Pony Club Young Rider Award - awarded to the highest scoring junior rider (sponsored by Lida Sease in honor of Pinchona Pony Club members past and present)
Horse of Color Award – awarded to the highest scoring horse of color - paint, Appaloosa, palomino, dun, buckskin or other unusual color (sponsored by Martha Scott)

Introductory Level and USEA tests will be ridden in a small (20 x 40 m) arena. All other tests will be ridden in a standard (20 x 60 m) arena. The arena has mirrors along the perimeter and is sand footing. Warm up is on grass. Please longe only in designated area. All tests may be called. Protective headgear must be worn by all riders, at all times when mounted. Classes will be split if entries warrant, at the discretion of the show management. "Schooling show attire" requested; otherwise, USEF rules apply (www.usef.org). Concessions will be available on grounds. Limited stabling available – \$35/night, shavings included. Please call or email for reservations. Camping is \$10/night per camper or tent. Please park only in designated areas. No refunds after the closing date. Late entries will be accepted at the discretion of the show management. \$30 returned check fee. Times will be emailed on Thursday evening before the show – please include your email address on the entry form (please call for times on Thursday if you do not email). **NO DOGS, PLEASE!**
